Priority 1

High quality **local provision for local children** - wherever possible, we will meet the needs of Haringey's children who require support to meet their SEND needs or who are educated in Alternative Provision within or close to our own borough.

Priority 3

We will continue to keep our Local Offer under review to **maintain the quality of our provision** and support and respond to emerging or changing needs.

Priority 4

We will continue to **listen and act on the lived experiences of children and young people** with SEND and who are educated in AP and their families or carers through authentic coproduction.

Priority 5

We will **embed independence and preparation for adulthood** throughout every phase of education and strengthen support at the point of transfer to their lifelong adult pathway.


